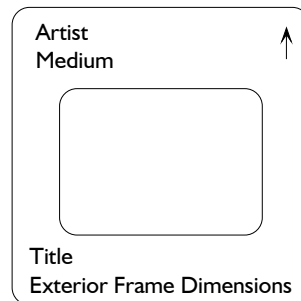

\$25 for one to three slides. Entry fees are non-refundable; US currency only. A 50% commission will be taken on paintings sold. Paintings are required to be available for sale.

Procedures

Eligibility

Open to all artists in AZ, CO, NM, OK, TX and UT. Submit only original, unsupervised work that has been completed within the past two years. Size of work is limited to 30 by 40 inches in any direction, inclusive of exterior frame dimensions. Submissions are open to the broadest range of representational two dimensional works. No three dimensional work, photography or computer generated images.

Slide Entry Information

Preliminary selection will be made from 35mm, 2x2 mounted slides (no glass) - one to three slides for \$25. Use only mylar tape if slides must be masked. Mail labeled slides, completed entry form, \$25 entry fee (check or money order made out to TSoPA), and a stamped, self addressed. #10 business sized envelope to: Taos Society of Portrait Artists, c/o Seamus Berkeley, 4198 NDCBU, Taos, NM 87571 - post marked by March 1. Final jury may omit any painting that contains unacceptable materials, is unsigned, or is not identical to the slide. Slides of accepted works become the property of TSoPA as a record of the exhibit. Your slide may be used for catalogue or publicity reproduction. Entry means that you have accepted the terms of this prospectus *. Your check is your receipt.

Presentation

Art must be gallery quality framed and ready for hanging. For media requiring glass, Plexiglas only.

Shipping and Return of Accepted Work

A \$20 fee will be charged for unpacking and repacking shipped work. Shipping instructions will be sent with acceptance notices.

Liability

All possible care will be taken with slides and work, but neither the Taos Society of Portrait Artists nor the Millicent Rogers Museum is liable for any loss or damage. Artists are encouraged to insure their own work.
